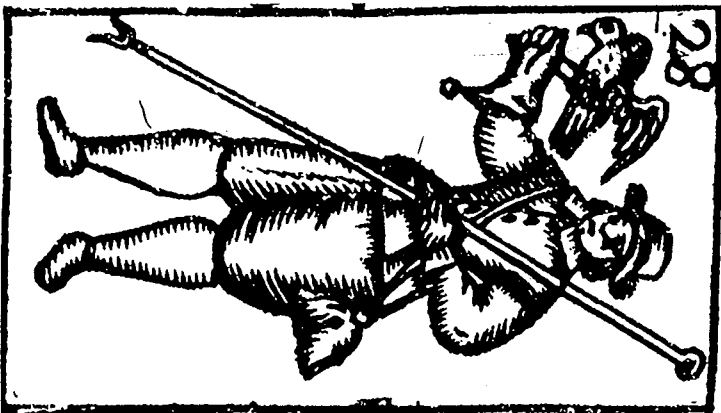

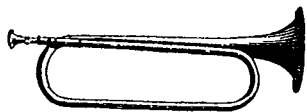

- The mundane difficulties occurring in the canton are making it impossible for the canton officers to perform the duties required of them.
- The canton membership pool is insufficient to replace officer positions if they became vacant. Because of the proximity to a military base, many of the members of the canton are military. Due to a transient population, we feel the pool of potential officers is too limited.

We have met with virtually all members of the canton about the situation and the overwhelming feeling is that no resolution to these problems is possible. The canton is factionalized and the factions will not communicate with each other. We feel that the best course of action is to disband the group and allow them to work out their mundane difficulties without the pressures of maintaining a formal S.C.A. group.

We are willing to work with and closely mentor the members of this group. We hope that personal growth will enable the members of the canton to better support a S.C.A. group.

Unto the populace of the Barony of Arn Hold,

Upon investigation of recent difficulties among the populace and officers of the Incipient Canton of Berg Heim, it is our decision that the status of this group as an incipient canton be revoked.

Our reasons are as follows:

- There has been a consistent lack of informative reporting from the canton officers to their baronial counterparts. Most reports have state "no activity this month." If there is no activity to report, there is concern as to why the group is a canton.
- There has been poor attendance of canton officers at baronial meetings.
- Canton populace is unable to separate mundane issues from S.C.A. issues. For example, religious intolerance has divided this group into two disparate factions. Accusations are flying between members and further destroying their ability to function as a group. These issues are too emotionally charged for the individuals involved to look at the issues objectively.
- Due to these conflicts, four of the eight paid members of the group are considering not renewing their memberships when they expire. Members of the canton do not want to attend local events. Baronial members are reluctant to attend canto events due to past experiences and tension levels in the canton.
- S.C.A. meetings, both populace and officer, have not been published in the local newsletter or mailings sent out to ensure that all of the populace is aware of the meeting times and locations. S.C.A. business had been discussed at the local Dungeons and Dragons gaming sessions. Members of the group which do not approve of gaming were uncomfortable feeling required to attend D&D sessions to find out about S.C.A. business. While the members that attend the D&D sessions maintain that they are not holding meetings during the D&D sessions, there have been no other meetings scheduled for S.C.A. business.

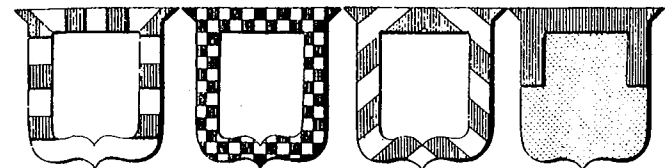

Estrella War Volunteers

Unto to the populace of Artemisia, doth Lady Leowyn Constance of Marshall send greetings. I am in hopes that everyone is doing well after this great holiday season and always.

The reason behind my letter is to introduce myself as the Artemisian Volunteer Coordinator for Estrella War. I will be working directly for Duchess Amanada and Mistress Myrddina the Volunteer Autocrats for Estrella War.

Volunteers are a very special part of any event. Without volunteers an event cannot get off the ground properly. Be that volunteer: an Autocrat or Feastocrat, or any of the other positions needed to pull off a successful event. No matter the size of an event volunteers are an essential part.

Estrella War is a huge event. There are roughly 7000+ volunteer hours to be filled during an event this size. Where do I get my numbers from?

From Here:

Tuesday at 1100 (when the gate opens) to Monday at 1100 is $6 * 24 = 144$ hours the park will be open. During these 144 hours at least 50 volunteers are needed per hour $144 * 50 = 7,200$ hours for normal operation.

The above figures do not include all the setup which will be done Sunday and Monday and all the cleanup after the War. This additional work is performed by our cousins in the Principality of the Sun.

What I am asking from you my fellow populace members is in addition to your 15 - 23+ hour drive to the War is to provide the Volunteer staff with 4 - 6 hours of your time. Also, to divide your time in half - half your hours to go to your local group, the other half to go to the Principality of Artemisia soon to be a Kingdom.

Volunteering at Estrella provides needed funds for your local group and for our Principality. Funds which are needed for the purchase of Crowns, Thrones etc. This is a good time for us to earn these funds by volunteering at the War.

I have sent sign-up packages out to the seneschals of Artemisia, along with a listing of job descriptions which will all appear over the server and in the Sage.

I am here to answer any of your questions and assist you at the War. There is a web site for Estrella also: <http://www.estrellawar.com/>

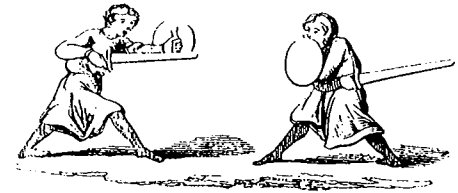
